## An Overview of SIFMA’s Anti-Money Laundering & Financial Crimes Conference

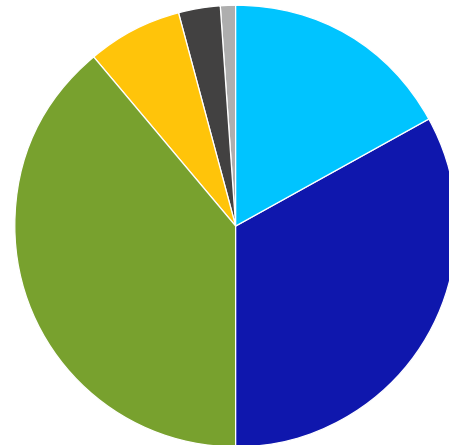
